

Intellectual Property Agreement: Buyer (distributor and end-customer), by purchasing the Equipment, acknowledges and agrees that the Equipment embodies and/or utilizes Seller's (Genizer LLC) valuable intellectual property, know-how, and trade secrets, including, without limitation, confidential proprietary information associated with the design, operation, and use of the interaction chamber and all other components associated with such Equipment. Buyer hereby agrees, represents, and warrants that it will not (nor will it aid, assist, or permit any other person or entity to): (i) tamper with the Equipment, including specifically the interaction chamber thereof, (ii) utilize any imaging equipment or other modality to reveal the inner structures and/or designs of the Equipment, including specifically the interaction chamber, high pressure homogenizer and liposome extruder thereof, (iii) attempt to disassemble or reverse engineer the Equipment, including specifically the interaction chamber and homogenizer thereof, or any interaction chambers and homogenizers purchased, rented or used by it, or (iv) otherwise discover and/or utilize any of the aforementioned intellectual property, know-how, and trade secrets of any aspect of the Equipment. Buyer further agrees, represents and warrants that it will not disclose (nor will it aid, assist or permit any other person to disclose) any information which it may, incidentally or otherwise, learn or discover about the materials and methods of construction, design, assembly, functioning, geometries, measurements and tolerances of the internal components of the Equipment, including specifically the interaction chamber and homogenizer. Buyer furthermore agrees that Buyer shall be liable to Seller for any and all actual and potential, direct and indirect, incidental and consequential damages, including, without limitation, lost profits arising from or related to any violation of these provisions, as well as any and all equitable relief as a court may impose, to remedy any such violation. Buyer shall not post negative information of Seller, online or in other venues or formats. The minimum penalty for violation of this Intellectual Property Agreement is 200% of the unit price. The minimum penalty for violation of this clause is 200% of unit price.

Disclaimer. Buyer agree NOT to direct the inlet or outlet of high pressure devices and equipment supplied by Seller (including high-pressure homogenizer, extruder, interaction chamber and valve) toward any person or object, lest they cause a safety issue and/or property loss. Buyer acknowledge that the personal shield is recommended in the operation of the high-pressure homogenizer and extruder, and that the high-pressure homogenizer and extruder are recommended to be operated in the shielded hood or space. Buyer should NOT directly touch the conductive material or any part of the high-pressure homogenizer when the electricity is on. Buyer shall be held completely responsible for any and all results of any violations on their part of the instructions and recommendations listed in this clause, as well as any other unsafe practices or actions they might take.
